| NOTES/OUTCOME | <p>HB 191 had its first hearing and Ben stated it went well. It is now out of committee. This bill concerns separate criminal offenses involving children. Ben said there was no opposition. We will monitor.</p> <p>Bill Mercer is working on a bill similar to LC 1593 concerning the definition of physical force and bodily injury. We will continue to monitor for this bill.</p> <p>HB 2 We will monitor this bill as to our concern about victim funding. Currently we receive \$120,000 a year from the state/feds. We are concerned that we may lose the funding for family victims if passed.</p> <p>Brodies Law is not in bill draft as this time. Our concerns are that funding may go from the YWCA program for family violence to civil issues. This has the potential of hurting our interests. We will continue to monitor.</p> |
