SHPO Visit – Lora handed out the questionnaire sent by SHPO for the CLG review scheduled for July 29th at 8:00 a.m. This will be an informal meeting as no business will be conducted. This meeting will be an overview of the YHPB CLG program with a review of the questionnaire.

First Interstate Grant Electronic Walking Tour – Lora distributed information regarding First Interstate Bank's grant program. It appears that \$1000 could be asked for. Discussion included the development of a master contact list to discuss the project and solicit funds. Lora and Kevin will work on an introductory letter with information about the project for YHPB members to use to contact their contacts. Members will send who they would like to contact to Lora and she will develop a master list so there is no double contacting. If YHPB can raise some funding through other sources, it may help with an application to First Interstate. Also, the Chamber did mention that if the project was short on funding, it may be able to contribute.

CDBG Rehab 460 Jackson – Members were given a brief overview of the proposed project. After review the YHPB recommended that if feasible that the 2/2 windows be replaced with similar 2/2 vinyl windows. Also, the front entry door has a diamond pattern window; if feasible the board would like to see a door that would have some similar architectural feature.
