MEETING MINUTES

December 18, 2012

The minutes of the September meeting were approved on a motion by Julie, seconded by Nancy.

Public Comment – None.

Certificate of Appropriateness – 2905 Montana Avenue - Emily began the discussion by showing the board examples of the tile they are proposing to use as replacement. The windows, which are not original will be replaced and framed with re-claimed wood from Wyoming. Kathleen asked about the ghost sign on the side of the building, do they have any plans to do anything with that sign. Emily responded that at this time they will probably just let the ghost sign remain. Kevin stated that trying to even preserve the sign is dangerous and it is better to let them be. Kevin asked how many tables does the restaurant hope to have, Emily responded that they would like to have 75 tables. The existing awning railing will be removed to allow for more natural light into the space. They currently have two apartments upstairs and both are occupied.

Kathleen opened the public hearing, there was no public comment and the hearing was closed. Nancy recommends approval of the COA as submitted, seconded by Julie. Approved on a 3-0 vote.
