Community News

Garfield Historical Building Dedication, Friday, May 2:

YHPB board members, Tabatha Butler, Liz Harding, and Nancy Curriden, along with Lora Mattox and Kevin Kooistra, attended the Garfield Historical Building Dedication, on Friday, May 2 from 1:30-3:30. Representatives from the Yellowstone Boys and Girls Ranch, as well as Commissioners Kennedy and Reno, and City Council members Ronquillo (former) and Yakawich of Ward 2 also participated. Mattox presented a short talk about the National Register of Historic Places and the work of the YHPB. Kevin Kooistra presented a special Program about the Architectural Styles and History of the Billings Southside. NOTE: YHPB should do an oral history with Jim Ronquillo, who is very versed with the life of Billings' south side.

DeGrenier and Kooistra, working from the previous work of Ann Kooistra-Manning, created a 30+ minute power point of the Architectural Styles and History of the Billings Southside. They photographed properties and defined the architectural styles of about 50 homes and buildings. The neighborhoods of the south side are some of the oldest in Billings and thus offer the greatest diversity in architectural styles. Added a new section to the power point that shares the unique history of the south side. This YHPB talk is now available for public programs.

Thanks to Regina Demis, Director of Public Relations, Yellowstone Boys and Girls Ranch for the invitation to participate. Sent the Yellowstone Boys and Girls Ranch documents and materials relating to the history of the Yellowstone Boys and Girls Ranch. Sent KTVQ historic photographs of Garfield School for their news program that evening.

Montana State Parks, April 23, 4:00 - 7:00 pm.

Responding to emails from the SHPO and Montana Preservation Alliance (MPA), Kevin Kooistra attended the State Parks strategic planning meeting at Pictograph Cave State Park. Following the lead of MPA, Kooistra added a voice for heritage and cultural values for Montana's heritage parks, such as Pictograph Cave and Plenty Coups State Park.

The National Register of Historic Places:

A quick review of the number of buildings listed on the National Register in Yellowstone County, including the contributing buildings within the two downtown historic districts in Billings, is fifty properties.


Community News
