Public Comment

Smith raised the issue of security of patrons at the Library after dark. Cochran noted that the Library has installed security cameras and hired an additional security guard; however it has no control over the properties across the street.

Fong inquired as to why the Library closes on Sunday during the summer months. Cochran noted that he initiated Sunday hours during the school year without any additional staff in the early 1990s and that the 1994 mill levy passed provided enough funding for the Library to open on Mondays for the first time in more than a decade. He reported that the only large Montana public libraries to offer Sunday hours year around have more staff than the Billings Public Library does; some offer no Sunday hours at any time of year.

Foundation report

Rose reported that:

- Food for Thought was successful and that the Foundation raised an additional \$4,000 for books during the event.

- The Foundation is revising their investment policies.

Friends of Library

Bach noted that:

- The Friends of the Library (FOL) have 110 members, with 25 volunteers and about ten active members doing a majority of the work. The FOL would like to be seen as a volunteer organization as well as fund raising.
- The book drive was extremely successful and she discussed the process of how the books are handled and distributed.

- The Book Nook has raised \$2,000 in four months and the FOL has received \$600 in internet sales.
- The FOL now have a new logo.

Building Project Update

Cochran noted that the demolition of the old building is not proceeding as quickly as expected which will push the completion of the parking lot back to October. He noted that work has begun on removing the temporary sidewalk crossing in front of the old building.

High Plains Book Awards Committee report

Rose reported that the finalists have been selected and the Committee is expecting a good turnout for the Awards ceremony scheduled for October 25. He noted that the Library will be sponsoring a table.

Fong distributed copies of the June 2 High Plains Book Awards Strategic Planning meeting notes. She discussed the meeting and purpose of the planning process.

Cochran reported that Programming Committee Chair McKinney has resigned. Cochran and Richardson will serve as Co-Chairs of the Committee.
