

## Billings City Administration Weekly Report

March 29, 2019

- 1) **SB 340 - 406 Impact District legislation** – SB 340 failed on a tie vote of 6-6 in committee yesterday morning. Yesterday afternoon, Senator Webb attempted to “blast” the bill on the Senate floor and it also failed by a razor thin margin of 24-25. Attempts to reconsider the “blast” today were not successful. Monday is the transmittal deadline.

After the dust settles, the strategy partners will sit down and have a series of candid conversation to discuss what we did well and what we needed to do better to be successful and how do we move forward to implement the OBS Plan. Character is often more clearly distinguished by how we responds to losing rather than winning.

- 2) **Office of Public Defender legislation (OPD)** – Several attempts have been made to shift OPD costs from the State to local governments (SB 315, HB 2, HB 773). Representative Mercer has been helpful steering the discussion to an interim study bill. We support this approach and plan to dedicate resources to this interim committee or risk finding ourselves responsible for significant new costs after the 2021 legislative session. We will continue tracking these issues closely until the session ends.
- 3) **Legislative Update** - Monday’s work session will begin with a conference call with Greg Dorrington and Aimee Grmoljez providing an update on the session. See attached legislative tracking document.
- 4) **Stillwater Building** - Monday Denis Pitman, Katy Easton and I met with Joe Holden to discuss three items; the agreement between Joe and the downtown tax increment finance district (TIF); Joe’s perspective on the OBS Plan and SB 340; and how the city and county can work together to purchase or lease space in the Stillwater Building.

Joe has not signed the agreement approved by the city council to incentivize the redevelopment of the Stillwater Building includes \$1.5 million in incentives from the downtown TIF district. It was clear from the discussion that there are disagreements regarding the conditions that are tied to the \$1.5 million contribution. No money has been distributed. We also discussed Joe’s active work to kill SB 340. Joe believes the One Big Sky Plan and SB 340 create an uncompetitive disadvantage for the Stillwater project. Finally, we began discussion on how the city and county can work together to purchase or lease space in the Stillwater building. None of the issues were resolved and conversations will continue in the upcoming weeks.

- 5) **Budget Presentations** – Budget presentations to Kevin, Andy and I will wrap up next week. We will balance the budget in the upcoming weeks and prepare for public presentations throughout April and May.

- 6) **Board meetings** – The Heights Task Force spent most of their time discussion issues and opportunities related to the school district (SD2). The high school’s critical high school operation levy will be on the ballot this May (Billing’s voters haven’t passed a high school levy since 2012) We also discussed continued efforts to improve safe routes to Medicine Crow school.
