

## Billings City Administration Weekly Report

April 12, 2019

### 1) Legislative Update – also see attached Crowley Fleck report

- a. **HB 773** – shifts costs from the State to local government for the Office of Public Defender. With much effort by MLCT and MACo, this bill was turned into a study bill and then sent to Senate Finance, where proponents asked that the bill move forward without amendments. Senate Finance, however, amended the bill modifying how the task force will be staffed, committee members and reporting. Notably, the Committee also added an amendment that would fund OPD through a fixed percentage reduction of the entitlement share amounting to about \$180,000. A fixed percentage for the local government contribution would not take effect until 2021. The entitlement share reduction for the City of Billings as amended would be \$19,495. MLCT is actively trying to kill this bill and has asked for our assistance to do so. Expect this will go to the Senate floor Saturday or Monday. Please call local delegation members and ask them to vote this bill down.
- b. **HB 749** – I testified in favor of Rep. Zolnikov’s human trafficking bill Thursday morning. Generally revise human trafficking laws, would give the city authorization to check license compliance in spa/massage businesses. It also establishes a 2-person human trafficking task force in the Department of Justice. The bill sailed through the House and had a hearing in the Senate Judiciary Committee yesterday. The bill passed in executive action this morning 7-3.
- c. **SB 147** – the human trafficking bill carried by Sen. Margie MacDonald passed Appropriations by a vote of 21-1. This will go back to the House floor final votes.
- d. **SB 160** - Current estimates from the Montana Municipal Interlocal Authority (MMIA) estimate that the bill will increase the City’s costs by over \$750,000 annually. It will return to the Senate for concurrence with the House amendments today on 2<sup>nd</sup> reading.
- e. **HB 325 & 357** - Billings, along with the MLCT, MACo, School Board Superintendents and School Boards opposed HB 325 & 357. The bills are in the process of being sent to the Governor for signature. The Governor has been asked to veto the bill. The amendatory veto language being proposed to HB 325 would preserve the authority of local governments to regulate certain firearms in public spaces, as well as preserve school districts’ ability to control conduct and activities that occur in schools within their district; it would allow schools and local governments to continue regulating firearms.
