

RESOLUTION NO. 01-17784

A RESOLUTION OF THE CITY OF BILLINGS, MONTANA,
DISCONTINUING AND VACATING a portion of LILLIS LANE between
24th Street West and 25th Street West.

WHEREAS, a proper petition was filed with the City Council of the City of Billings, Montana, as per Section 22-601 BMCC, requesting discontinuance and vacation of a portion of LILLIS LANE between
24th Street West and 25th Street West as described hereinafter; and

WHEREAS, a public hearing was properly noticed and held as required by law.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF BILLINGS, MONTANA, AS FOLLOWS:

1. DISCONTINUANCE AND VACATION. Pursuant to Sections 7-14-4114 and 7-14-4115, M.C.A., a portion of LILLIS LANE between 24th Street West and 25th Street West and more particularly described on *Exhibit "A"* attached, is/are hereby discontinued, abandoned and vacated.
2. PUBLIC INTEREST. The discontinuance, vacation and abandonment of the above described a portion of LILLIS LANE between 24th Street West and 25th Street West is in the best interest of the public and can be done without any public detriment. Ownership of the vacated area will revert to the adjacent owner – the Good Shepherd Lutheran Church.

Exhibit A

Parcel A

That portion of Lillis Lane adjacent to Lot 1, Block 1, Lillis Subdivision (Second Filing) being bounded and described as follows, to-wit:

Beginning at the northwest corner of said Lot 1; thence on and along a northerly projection of the east line of the alley in said Block 1 N00 16'W a distance of 36.60 feet to a point on the northerly line of said Lillis Lane; thence on and along said northerly line S73 14'20"E a distance of 146.42 feet to a point on the northerly projection of the west line of 24th Street West; thence on and along last said projection S00 16'E a distance of 36.60 feet to the northeast corner of said Lot 1; thence on and along the northerly line of said Lot 1 N73 14'20"W a distance of 146.42 feet to the point of beginning containing 5,125 square feet, more or less.

Parcel B

That portion of Lillis Lane adjacent to Lot 15, Block 1, Lillis Subdivision (Second Filing) being bounded and described as follows, to-wit:

Beginning at the northwest corner of said Lot 15; thence on and along a northerly projection of the east line of 25th Street West N00 16'W a distance of 36.60 feet to a point on the northerly line of said Lillis Lane; thence on and along said northerly line S73 14'20"E a distance of 135.96 feet to a point on the northerly projection of the west line of the alley in said Block 1; thence on and along last said projection S00 16'E a distance of 36.60 feet to the northeast corner of said Lot 15; thence on and along the northerly line of said Lot 15 N73 14'20"W a distance of 135.96 feet to the point of beginning containing 4,759 square feet, more or less.
