

RESOLUTION NO. 99- 17501

A RESOLUTION LEVYING AND ASSESSING A REFUSE FEE TO DEFRAY THE COST OF COLLECTION AND DISPOSAL OF SOLID WASTE FOR THE YEAR 1999 WITHIN THE CITY OF BILLINGS, MONTANA.

WHEREAS, the City made the annual determination of charges as provided in Billings, Montana City Code, Section 21-229, and

WHEREAS, extensions of those charges have been made on individual properties provided in Billings, Montana city Code, Section 21-230, and

WHEREAS, Billings, Montana City Code 21-231 et. seq. provides that the City shall provisionally pass and finally pass a resolution levying and assessing the refuse fees in accordance with the extension.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF BILLINGS, MONTANA, AS FOLLOWS:

1. ANNUAL REFUSE FEE. That for the purpose of defraying the cost of collecting and disposing of solid waste for the year 1999, there is hereby levied and assessed a basic special tax upon all lots, or portions of lots as provided in the schedule of extensions as computed, extended, compiled and stored in the City Computer Center and available as a printed document in the office of the Solid Waste Division of the City of Billings, at 302 Edwards Street, Billings, Montana.

2. DISPOSITION OF COLLECTIONS. The monies collected from taxes shall be paid into the Solid Waste Fund of the City of Billings.

3. NOTICE OF HEARING. On Monday, **September 27, 1999** at 7:30 o'clock p.m., or as soon thereafter as the matter may be considered on the agenda in the Council Chambers of the City Hall, Billings, Montana, the City Council will hear objections to the final adoption of this Resolution. The City Clerk is hereby directed to publish notice thereof once, at least five (5) days prior to the hearing, in the Billings Times.

4. CERTIFICATION. The City Clerk is hereby directed upon final passage and approval of this Resolution to certify a copy thereof to the City Finance Director of the City of Billings, Montana, who shall certify a copy to the Yellowstone County Clerk and a copy to the Yellowstone County Assessor.

5. EFFECTIVE DATE. This Resolution shall be effective upon final adoption.
