

RESOLUTION NO. 98-17424

A RESOLUTION RE-LEVYING AND RE-ASSESSING A TAX UPON A PORTION OF THE PROPERTY IN ALLEY APPROACH WORK ORDER NO. 94-02#03 (ASSESSMENT # 9597), IN THE CITY OF BILLINGS, MONTANA, FOR THE PURPOSE OF RE-LEVYING AND RE-ASSESSING A PORTION OF THE COST AND EXPENSE OF MAKING IMPROVEMENTS THEREIN.

WHEREAS, THE CITY CREATED ALLEY APPROACH WORK ORDER NO. 94-02#03 AND
