ADMINISTRATIVE ORDER NO. 128

Administrative Order Number 118123, dated October 29, 2010 March 6, 2013, is hereby amended to adopt the 2012 International Building Code, 2012 International Mechanical Code, 2012 International Existing Building Code, 2012 International Fuel Gas Code, 2012 Uniform Plumbing Code, and 2011 2014 National Electrical Code. All other portions of Administrative Order Number 118123 as set out below remain in full force and effect.

Pursuant to the authority granted to the City Administrator in Section 6-201, BMCC, and Section 50-60-301(1)(b), MCA, the following building, electrical, plumbing, and mechanical codes and all accompanying appendices, amendments and modifications adopted by the Building Codes Bureau, Montana Department of Labor and Industry, as set out in the Administrative Rules of Montana, as amended from time to time, are hereby adopted by reference, except as otherwise noted in chapter 6 of the Billings, Montana, City Code and except any regulations not applicable to local government jurisdictions.
