

RESOLUTION NO. 96-17134

A RESOLUTION LEVYING AND ASSESSING A TAX UPON ALL PROPERTY IN ALLEY APPROACH WORK ORDER NO. 95-02#03(ASSESSMENT # 9698), IN THE CITY OF BILLINGS, MONTANA, FOR THE PURPOSE OF LEVYING AND ASSESSING THE COST AND EXPENSE OF MAKING IMPROVEMENTS THEREIN.

WHEREAS, THE CITY CREATED ALLEY APPROACH WORK ORDER NO. 95-02#03 AND

WHEREAS, IT IS NECESSARY TO LEVY AND ASSESS A TAX TO DEFRAY THE COST AND EXPENSES OF SAID DISTRICT, NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF BILLINGS, MONTANA AS FOLLOWS:

1. LEVY AND ASSESSMENT
