

**RESOLUTION NO. 17-10623**

**A RESOLUTION OF THE CITY OF BILLINGS, MONTANA, TO  
DISCONTINUE SPECIAL IMPROVEMENT LIGHTING  
MAINTENANCE DISTRICTS NO. 269, NO. 274, AND NO. 281 OF  
THE CITY OF BILLINGS, MONTANA.**

**WHEREAS**, the City Council of the City of Billings, Montana, on the 13th day of December, 1999, passed Resolution 99-17533, a Resolution to Create a Special Improvement Lighting Maintenance District designated as No. 269; and

**WHEREAS**, the City Council of the City of Billings, Montana, on the 13th day of November, 2000, passed Resolution 00-17641, a Resolution to Create a Special Improvement Lighting Maintenance District designated as No. 274; and

**WHEREAS**, the City Council of the City of Billings, Montana, on the 13th day of September, 2004, passed Resolution 04-18187, a Resolution to Create a Special Improvement Lighting Maintenance District designated as No. 281; and

**WHEREAS**, the City Council of the City of Billings, Montana, on the 14th day of May, 2012, passed Resolution 12-19155, a Resolution amending the boundaries of Special Improvement Lighting Maintenance District designated as No. 281; and

**WHEREAS**, the remaining lights in Special Improvement Lighting Maintenance District No. 269 and Special Improvement Lighting Maintenance District No. 274 have been placed in Special Improvement Lighting Maintenance District No. 315; and

**WHEREAS**, the remaining lights in Special Improvement Lighting Maintenance District No. 281 and have been placed in Special Improvement Lighting Maintenance District No. 321; and

**WHEREAS**, Special Improvement Lighting Maintenance Districts No. 269, No. 274, and No. 281 should be discontinued; and

**WHEREAS**, pursuant to §7-12-4311 MCA, the City Council may, by resolution, discontinue a Special Improvement Lighting Maintenance District.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF BILLINGS, MONTANA, THAT:**

1. That Special Improvement Lighting Maintenance District No. 269 is hereby discontinued and the following tracts, pieces, lots or parcels of land shall be removed from assessment in this discontinued District:

- a. Lots 2 and 3, Block 1, Popleka Heights View Subdivision
- b. Lot 1, Block 2, Popleka Heights View Subdivision

2. That Special Improvement Lighting Maintenance District No. 274 is hereby discontinued and the following tracts, pieces, lots or parcels of land shall be removed from assessment in this discontinued District:
  - a. Lots 1, 2, 3, & 4, Block 1, Wal-Mart Subdivision
3. That Special Improvement Lighting Maintenance District No. 281 is hereby discontinued and the following tracts, pieces, lots or parcels of land shall be removed from assessment in this discontinued District:
  - a. Lot 2, Block 1, Hancock – Grand Subdivision, as recorded April 24, 2002, under Document Number 3173767;
  - b. Lot 1A, Block 1, of Amended Plat of Lots 1, 3 and 4, Block 1, Hancock – Grand Subdivision, as recorded November 24, 2003, under Document Number 3265172;
  - c. Lot 7, Block 2, Circle Fifty Subdivision, as recorded February 6, 1985, under Document Number 1339215;
  - d. Lot 6D, Block 2, of Amended Plat of Lot 6 Block 2, Circle Fifty Subdivision, as recorded June 16, 2004, under Document Number 3292596;

This Resolution shall become effective immediately upon its passage and approval.


