Calls for service 7800 in April. WE 961 calls. Suspicious 117, disturbances 72, welfare checks 50. What they are? Independent living space still a parcel of the same lot. So basically a big house with a small house on the same lot. Perhaps a basement conversion or a detached garage conversion or an attached part of the house that is converted.

Why have one? Affordable housing, independent living for smaller households, provides rental income to suit the home owners needs.

Where are they? Idaho Falls, Rapid City, Bismarck.

ADUs currently exist as a legal non-conforming unit most existing as basement apartments. Project recode is trying to simplify the regulations using lot width. June 18th at night in the city council chambers there will be a big presentation for the core drafts on the new zoning code.
