

ORDINANCE NO. 19-5724

AN ORDINANCE OF THE CITY OF BILLINGS, AMENDING
BILLINGS, MONTANA CITY CODE, CHAPTER 11,
ELECTIONS, IN PARTICULAR, SECTION 11-102(c),
WARD BOUNDARIES; AND CHANGING THE WARD
BOUNDARIES ESTABLISHED THEREIN BY ADDING
CERTAIN NEWLY ANNEXED REAL PROPERTY TO
WARD III PROVIDING FOR CERTIFICATION AND
REPEALING OF ALL ORDINANCES AND RESOLUTIONS
INCONSISTENT THEREWITH.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF BILLINGS, MONTANA:

1. AMENDMENT. Pursuant to Billings, Municipal City Code, Section 11-102(c) and the State Law, Billings, Municipal City Code, Section 11-102(c) Ward Boundaries is hereby amended by adding to Ward III the following described real property:

Tracts of land situated in the NW 1/4 of Section 19, T.1S., R.26E., Yellowstone County, Montana, more particularly described as:

Tract 2B of Amended Tract 2 Certificate of Survey No. 3594, Recorded March 01, 2019, under Document No. 3876931, on file and of record in the Records of Yellowstone County, (prior to the merging with Lot 1, Block 5 of Amended Plat of Lot 1, Block 5, Annafeld Subdivision First Filing, Recorded March 01, 2019, under Document No. 3876933);

Lot 2B, Block 1 of Amended Plat of Lot 2, Block 1, Adam And Mollie Walter Subdivision, First Filing, Recorded April 18, 2019, under Document No. 3880645, on file and of record in the Records of Yellowstone County, (prior to the merging with Lot 1A, Block 4 of Amended Plat of Lots 1 and 2, Block 4, Annafeld Subdivision First Filing, Recorded September 14, 2018, under Document No. 3862576);

Including all adjacent right-of-way of Elysian Road;

Containing 45.398 gross and 43.125 net acres more or less.

2. CERTIFICATION. Pursuant to Section 13-3-103, MCA, the above change and alteration is hereby certified to the election administrator by the City Council, and the City Administrator or his designee is hereby directed to certify the changes and alterations and to deliver a map showing the boundaries of the ward, the streets, avenues and alleys by name and the ward by number, to the election administrator not more than ten (10) days after the effective date of this ordinance.

3. **REPEALER.** All other ordinances, sections of the Billings, Municipal City Code and ordinances inconsistent herewith are hereby repealed.
