ADMINISTRATIVE ORDER NO. 146

Administrative Orders Numbers 128, dated 1/8/15, 129, dated 2/17/16, and 141, dated 2/7/20, are hereby repealed and replaced with the 2018 International Building Code, 2018 International Residential Code, 2018 International Existing Building Code, 2018 International Mechanical Code, 2018 International Fuel Gas Code, 2018 International Swimming Pool and Spa Code, 2018 Uniform Plumbing Code, 2018 International Energy Conservation Code, 2017 National Electrical Code, and 2018 NFPA 99C Gas and Vacuum Systems.

Pursuant to the authority granted to the City Administrator in Section 6-201, BMCC, and Section 50-60-301(1)(b), MCA, the following building, electrical, plumbing, and mechanical codes and all accompanying appendices, amendments and modifications adopted by the Building Codes Bureau, Montana Department of Labor and Industry, as set out in the Administrative Rules of Montana, as amended from time to time, are hereby adopted by reference, except as otherwise noted in chapter 6 of the Billings, Montana, City Code and except any regulations not applicable to local government jurisdictions.


