## **ORDINANCE 22-5822**

### **AN ORDINANCE OF THE CITY OF BILLINGS, CREATING A SECOND OFFICE OF MUNICIPAL COURT JUDGE; AMENDING CHAPTER 10 OF BILLINGS, MONTANA CITY CODE (BMCC) SECTIONS 10-202(a)(b)(c) MUNICIPAL COURT JUDGES, SECTION 10-205(a)(b) ANNUAL SALARY AND EXPENSES; ESTABLISHING A STAGGERED ELECTION CYCLE FOR THE MUNICIPAL JUDGES; AND PROVIDING AN EFFECTIVE DATE**

**WHEREAS**, pursuant to Sec. 10-101 of the Billings, Montana City Code (BMCC), there shall be a municipal court as prescribed by state law; and

**WHEREAS**, the City has previously created the office of a full time elected municipal court judge pursuant to Title 3, Chapter 6, MCA; and the provisions of BMCC Chapter 10; and

**WHEREAS**, §3-6-201, MCA and Sec. 10-202(b), BMCC provide for part-time assistant judges appointed by the elected municipal court judge and confirmed by the Billings City Council to serve with all the rights and responsibilities of a full-time judge; and

**WHEREAS**, the 2021 Montana Legislature amended §3-6-201, MCA, to remove the authorization for part-time assistant judges and effective April 10, 2022, Montana state law requires all municipal court judges to be elected; and

**WHEREAS**, it is in the interests of the City to establish a second full-time elected municipal court judge position to comply with State law, to manage the municipal court's caseload and to more efficiently administer justice in the City of Billings.

**NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF BILLINGS THAT:**

**Section 1.** That Chapter 10 of the Billings, Montana City Code (BMCC) is amended as follows and any sections not amended herein shall remain in effect:

#### **Sec. 10-202. - Municipal court judges.**

(a) There shall be two (2) full-time elected municipal court judges. A judge's term commences on the first Monday in January following the election. The judge shall hold office for the term of four (4) years and until a successor is elected and qualified. The terms of the municipal court judges shall be staggered.

(b) The city council may change the number of full-time municipal judges by ordinance.

(c) The chief judge of the municipal court shall be determined in accordance with title 3, chapter 6, of the Montana Code Annotated (MCA 3-6-101 et seq.).

**Sec. 10-205. - Annual salary; expenses.**

(a) Pursuant to MCA 3-6-203, the salary of the city municipal court judges must be fixed by ordinance or resolution.

(b) In addition to the foregoing, a municipal court judge shall receive his or her actual and necessary traveling expenses and all other necessary expenses as budgeted in the city's annual budget.

**Section 2.** The City Council hereby authorizes the creation of a second full time office of a municipal court judge to commence on the first Monday in January of 2024. The Billings City Council hereby requests the Yellowstone County Clerk - Elections Administrator to immediately commence with an election for the second full time municipal court judge to occur on November 7, 2023.

**Section 3. EFFECTIVE DATE.** This ordinance shall be effective thirty (30) days after second reading and final adoption as provided by law.

**Section 4. REPEALER.** All resolutions, ordinances, and sections of the City Code inconsistent herewith are hereby repealed.

**Section 5. SEVERABILITY.** If any provision of this ordinance or the application thereof to any person or circumstances is held invalid, such invalidity shall not affect the other provisions of this ordinance which may be given effect without the invalid provisions or application, and, to this end, the provisions of this ordinance are declared to be severable.





## **ELECTRONIC RECORD AND SIGNATURE DISCLOSURE**

From time to time, Carahsoft OBO City of Billings (we, us or Company) may be required by law to provide to you certain written notices or disclosures. Described below are the terms and conditions for providing to you such notices and disclosures electronically through the DocuSign system. Please read the information below carefully and thoroughly, and if you can access this information electronically to your satisfaction and agree to this Electronic Record and Signature Disclosure (ERSD), please confirm your agreement by selecting the check-box next to 'I agree to use electronic records and signatures' before clicking 'CONTINUE' within the DocuSign system.

### **Getting paper copies**

At any time, you may request from us a paper copy of any record provided or made available electronically to you by us. You will have the ability to download and print documents we send to you through the DocuSign system during and immediately after the signing session and, if you elect to create a DocuSign account, you may access the documents for a limited period of time (usually 30 days) after such documents are first sent to you. After such time, if you wish for us to send you paper copies of any such documents from our office to you, you will be charged a \$0.00 per-page fee. You may request delivery of such paper copies from us by following the procedure described below.

### **Withdrawing your consent**

If you decide to receive notices and disclosures from us electronically, you may at any time change your mind and tell us that thereafter you want to receive required notices and disclosures only in paper format. How you must inform us of your decision to receive future notices and disclosure in paper format and withdraw your consent to receive notices and disclosures electronically is described below.

### **Consequences of changing your mind**

If you elect to receive required notices and disclosures only in paper format, it will slow the speed at which we can complete certain steps in transactions with you and delivering services to you because we will need first to send the required notices or disclosures to you in paper format, and then wait until we receive back from you your acknowledgment of your receipt of such paper notices or disclosures. Further, you will no longer be able to use the DocuSign system to receive required notices and consents electronically from us or to sign electronically documents from us.

### **All notices and disclosures will be sent to you electronically**

Unless you tell us otherwise in accordance with the procedures described herein, we will provide electronically to you through the DocuSign system all required notices, disclosures, authorizations, acknowledgements, and other documents that are required to be provided or made available to you during the course of our relationship with you. To reduce the chance of you inadvertently not receiving any notice or disclosure, we prefer to provide all of the required notices and disclosures to you by the same method and to the same address that you have given us. Thus, you can receive all the disclosures and notices electronically or in paper format through the paper mail delivery system. If you do not agree with this process, please let us know as described below. Please also see the paragraph immediately above that describes the consequences of your electing not to receive delivery of the notices and disclosures electronically from us.

### **How to contact Carahsoft OBO City of Billings:**

You may contact us to let us know of your changes as to how we may contact you electronically, to request paper copies of certain information from us, and to withdraw your prior consent to receive notices and disclosures electronically as follows:

### **To advise Carahsoft OBO City of Billings of your new email address**

We do not require any other information from you to change your email address.

If you created a DocuSign account, you may update it with your new email address through your account preferences.

### **To request paper copies from Carahsoft OBO City of Billings**

To request delivery from us of paper copies of the notices and disclosures previously provided by us to you electronically, you must send us an email to [kampal@billingsmt.gov](mailto:kampal@billingsmt.gov) and in the body of such request you must state your email address, full name, mailing address, and telephone number. We will bill you for any fees at that time, if any.

### **To withdraw your consent with Carahsoft OBO City of Billings**

To inform us that you no longer wish to receive future notices and disclosures in electronic format you may:

- i. decline to sign a document from within your signing session, and on the subsequent page, select the check-box indicating you wish to withdraw your consent, or you may;
- ii. send us an email to [kampal@billingsmt.gov](mailto:kampal@billingsmt.gov) and in the body of such request you must state your email, full name, mailing address, and telephone number. We do not need any other information from you to withdraw consent.. The consequences of your withdrawing consent for online documents will be that transactions may take a longer time to process..

### **Required hardware and software**

### **Acknowledging your access and consent to receive and sign documents electronically**

Further, if you consent to receiving notices and disclosures exclusively in electronic format as described herein, then select the check-box next to 'I agree to use electronic records and signatures' before clicking 'CONTINUE' within the DocuSign system.
