RECOMMENDATION

Staff recommends that the City Council conduct a public hearing and pass the proposed resolution that spreads final assessments for SID 1417.

BACKGROUND (Consistency with Adopted Plans and Policies, if applicable)

The assessments for SID 1417 have been completed by the Finance Division and are ready to be re-spread on the tax rolls. SID 1417 was originally spread based on estimated costs and is now being re-spread based on the completed construction costs.

This project includes installation of water and storm drain system improvements and reconstruction of the roadway to widen and implement a roundabout at the Annafeld Parkway intersection. The project will also install street lighting along Elysian Road and the subdivision streets for Annafeld Subdivision, Third Filing and Annafeld North Subdivision, First Filing. The construction contract was awarded at the 5/24/2021 City Council meeting, and bonds were sold.

Letters to property owners notifying them of this hearing and the proposed assessment amount have been sent.

City Council may:

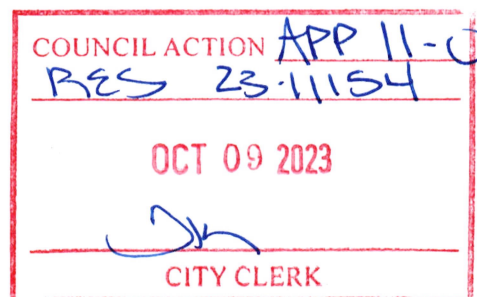
- Approve; or,

FISCAL EFFECTS

The actual cost of the project was \$2,445,935.75. This is 246,309.92 less than the original estimate that was spread to the district in 2021. The amount being assessed per property will be spread over the remaining 13 years of debt term, as stated in the resolution.

RESOLUTION 23 _____

**A RESOLUTION RELEVYING AND REASSESSING A SPECIAL
ASSESSMENT TAX UPON ALL BENEFITED PROPERTY IN A
SPECIAL IMPROVEMENT DISTRICT OR PROJECT KNOWN AS 1417,
IN THE CITY OF BILLINGS, MONTANA.**

WHEREAS, the City created a special improvement district or project known as 1417 and;

WHEREAS, it is necessary to relevy and reassess a special assessment tax upon each benefited property in the district or project area to defray the cost and expenses of said district or project. The original assessment was calculated on the bond sale cost. After construction was completed, the City adjusted the assessment by using the project cost; and

NOW THEREFORE, BE IT RESOLVED by the City Council of the City of Billings, Montana as follows:

1: RELEVY AND REASSESSMENT. That for the purpose of defraying the cost and expense of making improvements in a special improvement district or project known as 1417 of the City of Billings, Montana, there is hereby relevied and reassessed upon each lot or parcel of land described below, owned by persons respectively indicated, a special assessment tax payable in semi-annual installments with interest. The final publication was made at least 10 days prior to the hearing as provided in section 7-12-4177, MCA.

4: EFFECTIVE DATE. This resolution shall be effective upon adoption.
