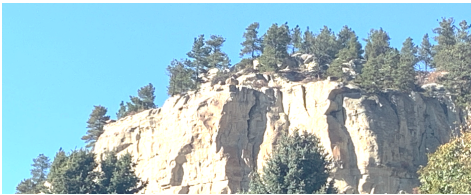

## RNTF Vice Chair & Acting Chair

The Board has proposed a change to the by-laws which would provide automatic succession to the Chair position by the Vice Chair, should the Chair position become vacant before the term is completed. Should the change pass, we will be opening nominations for Vice Chair during the February meeting. If it doesn't pass we will be opening nominations for Chair. We need a volunteer to fulfill either position. Please consider serving your neighbors by joining the RNTF Board.

An **All City Task Force meeting** was held January 23 which opened my eyes to the need to be better informed on issues which are community based, and not specific to the Rimrock Neighborhoods. As residents, we need to be aware and involved as much as possible. Trustworthy and unbiased communication is needed.

To fill this communication need, I would welcome members who have interest, or would like to learn more about community issues, to volunteer to provide RNTF membership factual information regarding those issues. All facts will be supported by documentation or public record. Issues such as West End Development will impact our neighborhoods and should be understood. Public Safety issues are the concern of all residents. Domestic violence, drugs, gangs, jail, mental health, human trafficking, land use, road development/improvement, etc. are just some of the opportunities to help RNTF members understand the issues from an independent source. Communication resources of the RNTF will be made available for reporting.

Leslie Cooke, our Secretary, has done an outstanding job of using communications channels to keep our membership informed and in touch with the community. Our challenge now is to keep the network key to understanding our neighborhood and community concerns.

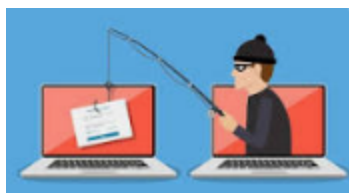

## NAVIGATING CYBER THREATS:

### UNDERSTANDING THE DIFFERENCE BETWEEN SPAM AND PHISHING

We're diving into a crucial topic – distinguishing between SPAM and PHISHING. Both are common cyber threats, but understanding their differences is key in safeguarding our digital identities. Let's break it down!

#### ✉ **SPAM: The Digital Junk Mail** ✉

- **What Is It?** SPAM is unsolicited digital messages, often sent in bulk. It's like the junk mail in your physical mailbox, but in your email inbox.
- **Purpose?** Mostly, SPAM is annoying yet harmless. It's often trying to sell you something, like those endless promotional emails.
- **Risk Level?** Generally low, but it can be a nuisance & sometimes a gateway to malicious content.

## DRUG CORNER:

Knowledge is power

### What is Fentanyl?



#### **Fentanyl:** A Powerful and Dangerous Opioid

- A synthetic opioid pain reliever, similar to morphine but 50-100 times more potent.
- It comes in two pill forms:
  - Pharmaceutical fentanyl: prescribed by doctors for severe pain management.
  - Illicitly manufactured fentanyl: illegally produced and sold, often mixed with other drugs without the user's knowledge.
- Cost varies in the \$20-\$30 range, but Washington State has seen costs as low as \$.50 /pill

#### **Dangers:**

- Highly addictive: Creates intense euphoria, leading to dependence and cravings.
- Overdose risk: Even small amounts can be deadly due to potency, causing respiratory depression and death.
- Unintentional exposure: Often mixed with other drugs like heroin, cocaine, or counterfeit pills, making users unaware of its presence.
- Widespread: A major contributor to overdose deaths in the U.S., with over 150 fatalities daily

#### **If you suspect a substance is fentanyl:**

1. Do not handle or use the substance. Leave it untouched and undisturbed. Even small amounts of fentanyl can be dangerous if absorbed through the skin or inhaled.
2. Call emergency services immediately. Remember: Fentanyl is extremely dangerous. If you or someone you know is struggling with opioid addiction, please seek help. There is hope for recovery.

### **Update on City Council business - from Ward 4 Member Scott Aspenlieder:**

*(note: Mr. Apenlieder prepared this update prior to the Monday 2/5 council meeting)*

**1 – County's Jail Expansion** – Commissioners have moved out a proposal, expanded from the original request/proposal from the City last fall, to build a 72-hour hold & arraignment expansion of the YCDF. Their proposal would include a 2-floor expansion with a total of 96 additional beds. Proposed cost of this project is roughly \$6mil. The Commission is confident it could be built & operational within 15-18 months. When Council put forward its proposal the thought was we needed something temporary that could be put up fast, creating an opportunity for detention to interrupt criminal cycles ensuring criminals get in front of a judge before release. The County has moved that from a temporary to a permanent facility expansion noting that it's a good idea & should be done quickly to assist law enforcement. The County has requested the City pay half the expense, with the City already having set aside \$500k in the FY24 budget.

City Council will be discussing the request at the Feb 5<sup>th</sup> Working Meeting & then would potentially take action Feb 12<sup>th</sup> to keep the Commission moving forward one way or the other. My position will be that Public Safety is the #1 priority in our community & this is certainly something we need to participate in to make sure it gets across the line. To be clear this would be done with both City &



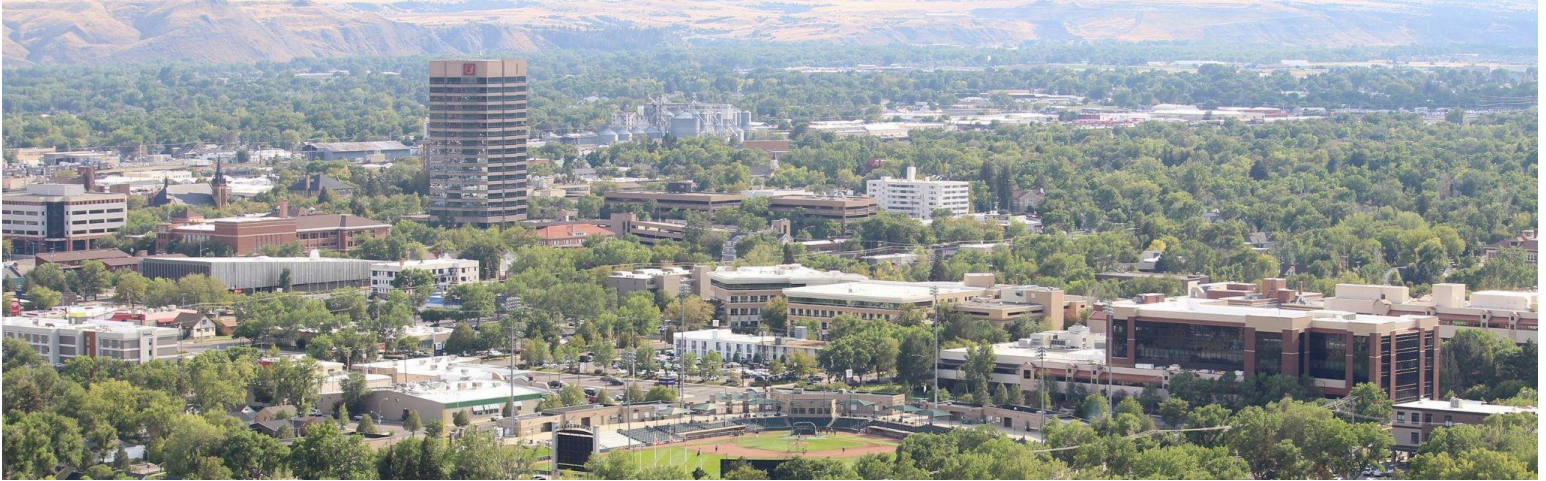

County using their existing authorities and not requiring either entity to go out for bond. It would be paid for with one time only money and then operation of the facility would be rolled into the YCDF. The City anticipates needing 20-24 beds for its misdemeanor criminals which is about 25% of facility capacity. There will be discussion about the appropriateness of the City participating in building a facility that is clearly the County's responsibility. My position is again that this is a need for our officers & for a system to interrupt criminals & assure that they get in front of a judge at least once before release. Regardless of whose responsibility it is, it is and will be funded by taxpayers who happen to be the same for both County & City in large part & it's a critical quick step to improving our system. I'll be supporting partnership with the County to get the facility built & hope to work with my counterparts to come together for improving our community's safety.

**2 – Family Violence Unit Development (FVU)** – Councilwoman Owen pushed forward an initiative to look at formation of a formal FVU within BPD. The basis of that was that over 50% of violent crime in Billings is tied to domestic or family violence. Chief St John will be presenting his thoughts & options for consideration to Council Feb 5<sup>th</sup> at the Working Meeting. As one would expect there are things that can be done to improve our existing DV investigators & process without additional officers, however those items are limited & mostly around efficiencies. Chief's memo to counsel outlines the potential to add 6 officers to establish a formal FVU supplementing the two officers already operating in that space within BPD. The projected cost is estimated at roughly \$747k to fully outfit & get those individuals in place. That'll be a discussion we'll have as part of budgeting for FY25 in March & April. At this point I'll be supporting that initiative with hopes of expansion & adding additional resources to BPD. We're in crisis mode for public safety right now & adding appropriate resources is imperative to starting to turn the corner. The rise in DV cases in our community justifies the need & proposed formation of a FVU with BPD. I look forward to that discussion & expansion of resources our BPD needs to effectively protect our community.
