ADMINISTRATIVE ORDER NO. 159

**Administrative Order No. 148, dated 3/27/24 is hereby repealed and replaced with this Administrative Order.**

**\*\*Any person who violates or permits or allows anyone to violate any of sections 24-412, 24-455, 24-456 (a)(1), or 24-462 is guilty of a municipal infraction and shall be fined as follows:**

**First citation: \$10**

**Second citation: \$20**

**Third citation: \$40**

**Fourth and subsequent citations: \$50**

**Imposition of the maximum fine for fourth and subsequent violations of any of these sections will continue in effect until no fewer than 365 consecutive days have passed without a violation by the person. Any violation by the person of any of these sections beyond that 365-day period will be fined as a first violation and restart the escalation of fines for subsequent violations until an additional 365 days have passed without a violation by that person.**

**This cycle of escalation of fines based on number of violations and requirement of 365 days of no violations before eligibility for a 1st offense fine is intended to be continuing in its application to any particular person who is a repeat violator of any of these sections.**
