Rimrock Rd just went through a chip seal project (also called “pavement preservation”)

COMMUNITY HEALTH CORNER



Blacklegged ticks identified in Eastern Montana



The state has announced the arrival of a tick species new to Montana and is asking for the public's help with surveillance.

Ixodes scapularis (“deer tick” or “blacklegged tick”) has been identified in Eastern Montana. This is the first time a blacklegged tick has been found in our state through active surveillance.

Blacklegged ticks transmit Lyme disease, Powassan virus disease, ehrlichiosis, babesiosis, anaplasmosis & hard tick relapsing fever.

The most common tick-borne illnesses in Montana are Rocky Mountain spotted fever, Colorado tick fever, soft tick relapsing fever & tularemia - spread by tick species already common in Montana.

Reducing exposure is the best defense against tick-borne disease. Treat clothing & gear with products containing 0.5% permethrin – used to treat boots, clothing & camping gear, and will remain protective through several washings.

Avoid wooded & brushy areas with high grass & leaf litter. Walk in the center of trails.

Use insect repellents containing DEET, picaridin, IR3535, Oil of Lemon Eucalyptus (OLE), para-menthane-diol (PMD) or 2-undecanone.

After coming indoors, check your body, gear, clothing & pets for ticks.

Early symptoms of tick-borne illnesses are often similar, & include fever, persistent headaches & body aches.

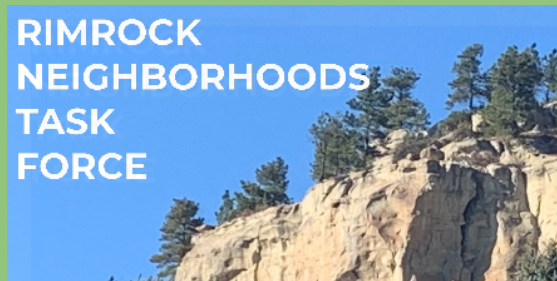
