

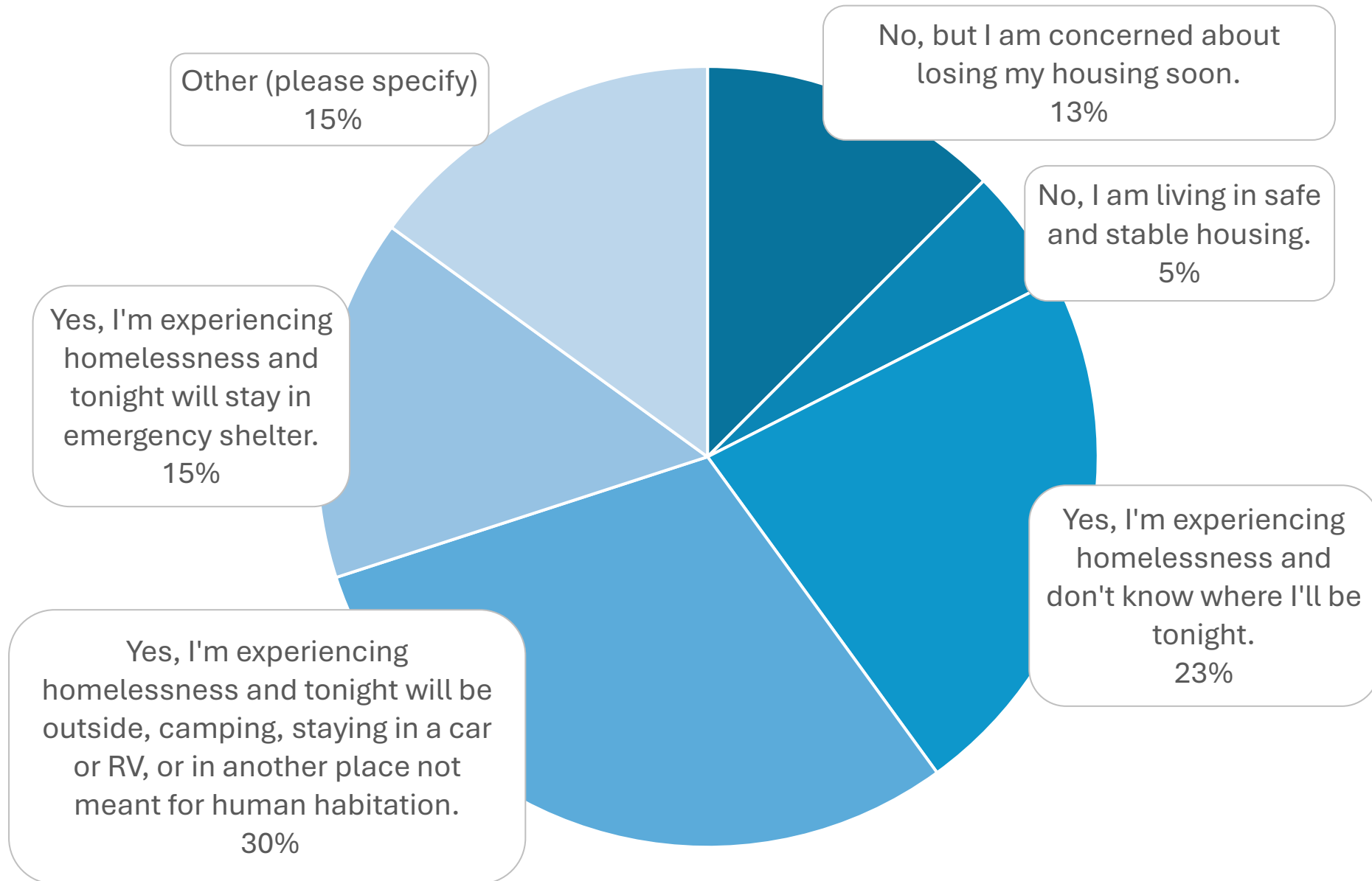

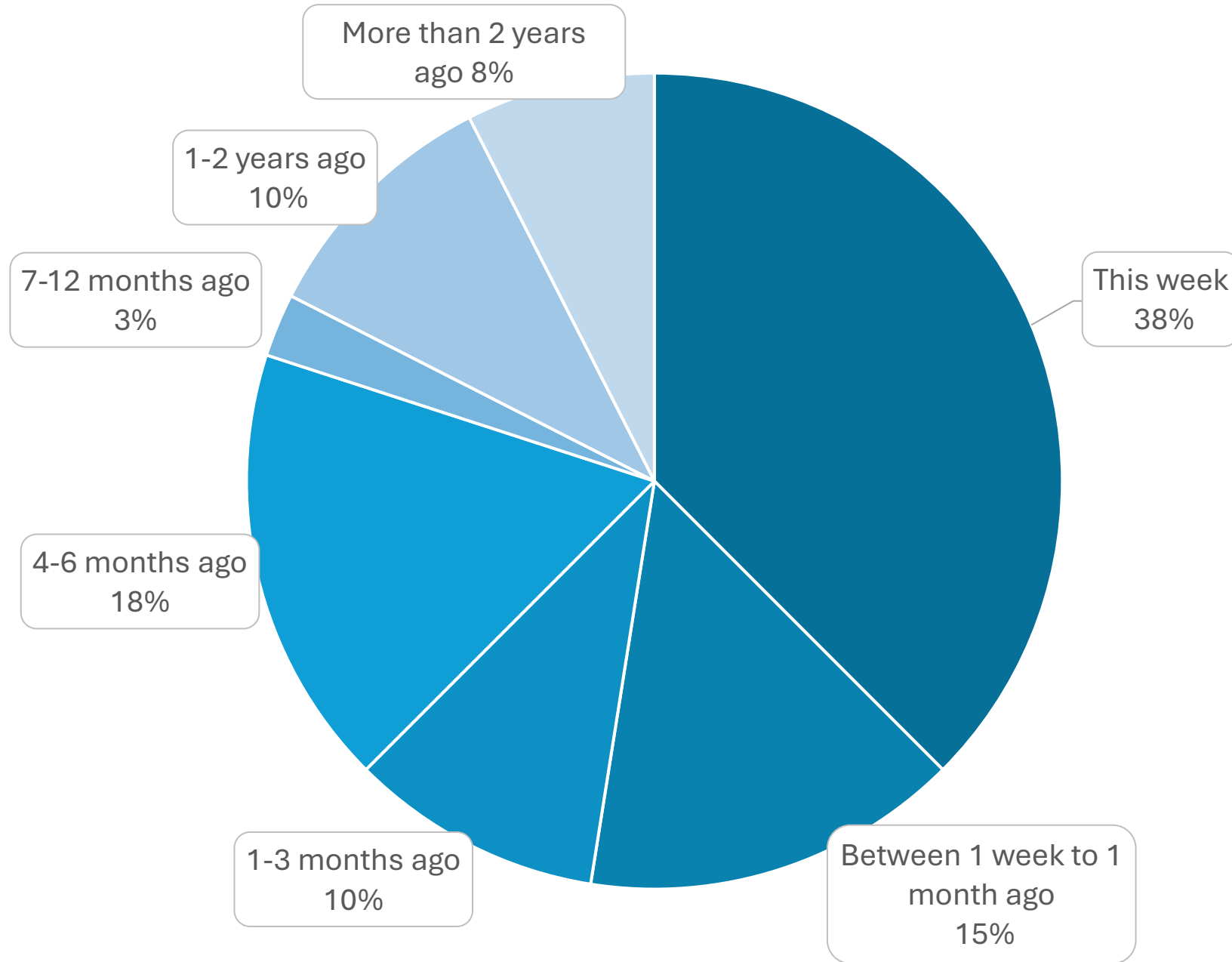

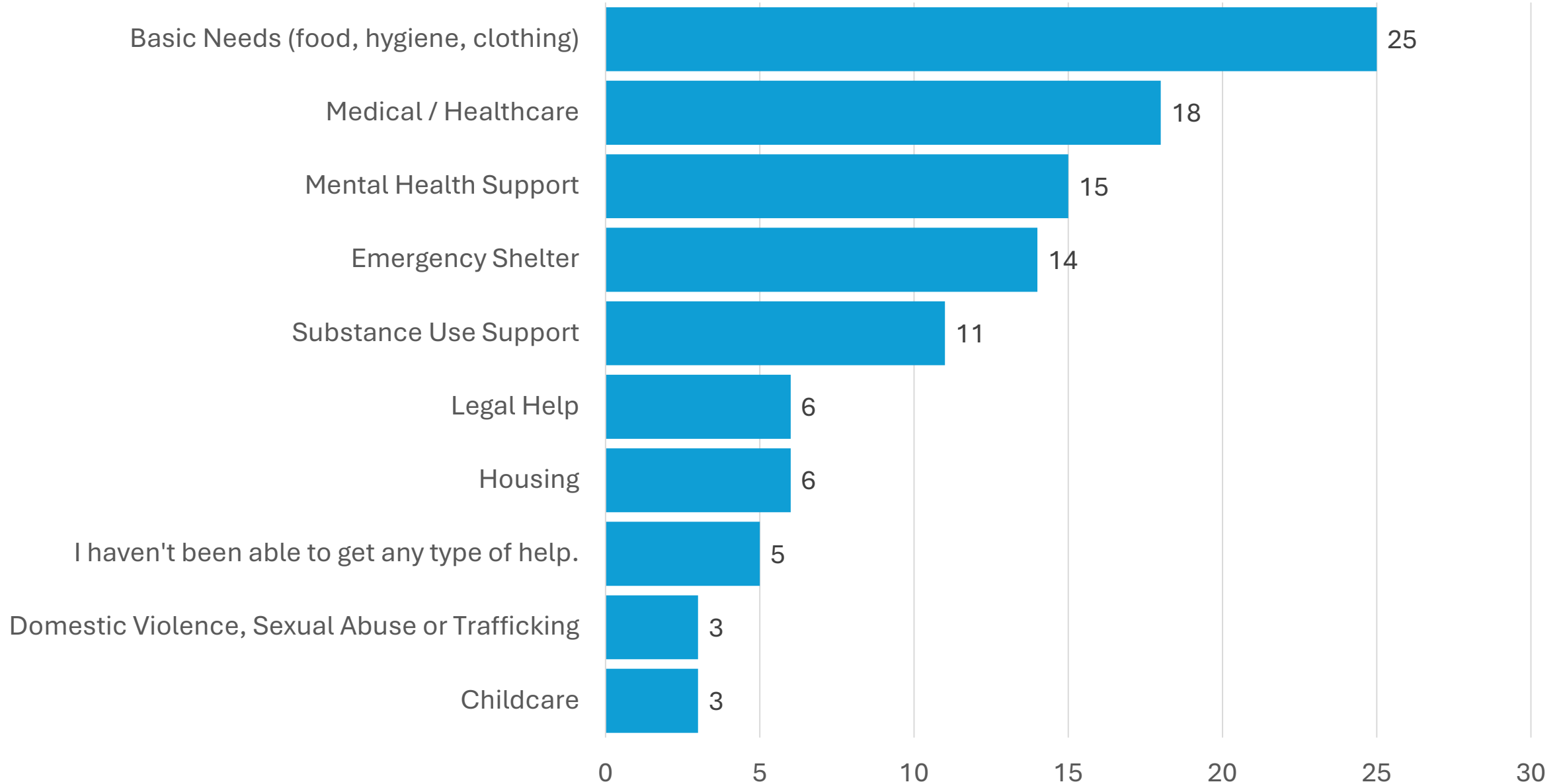
## Are you currently experiencing homelessness?



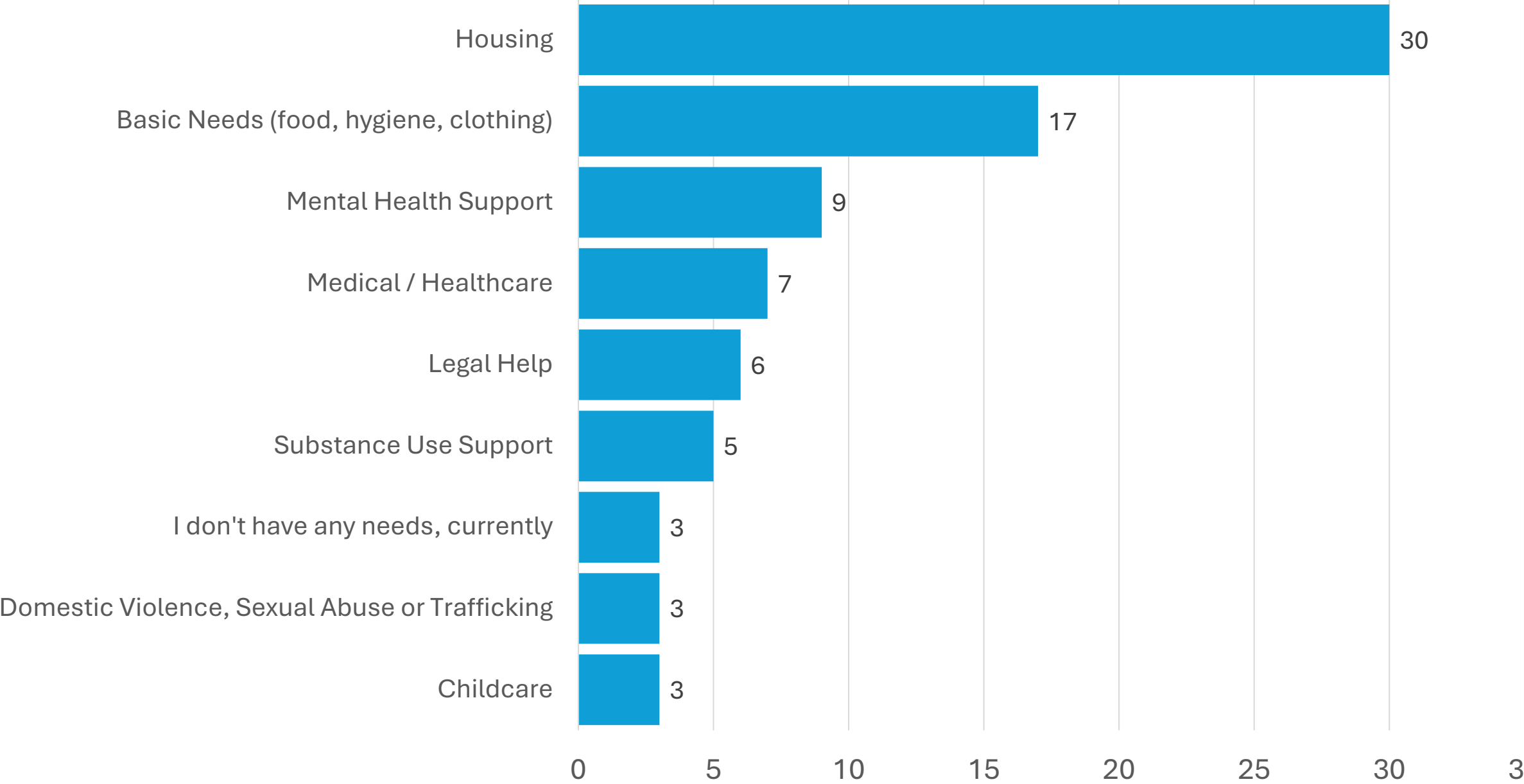
## When did you last attempt to access housing, shelter or supportive services?



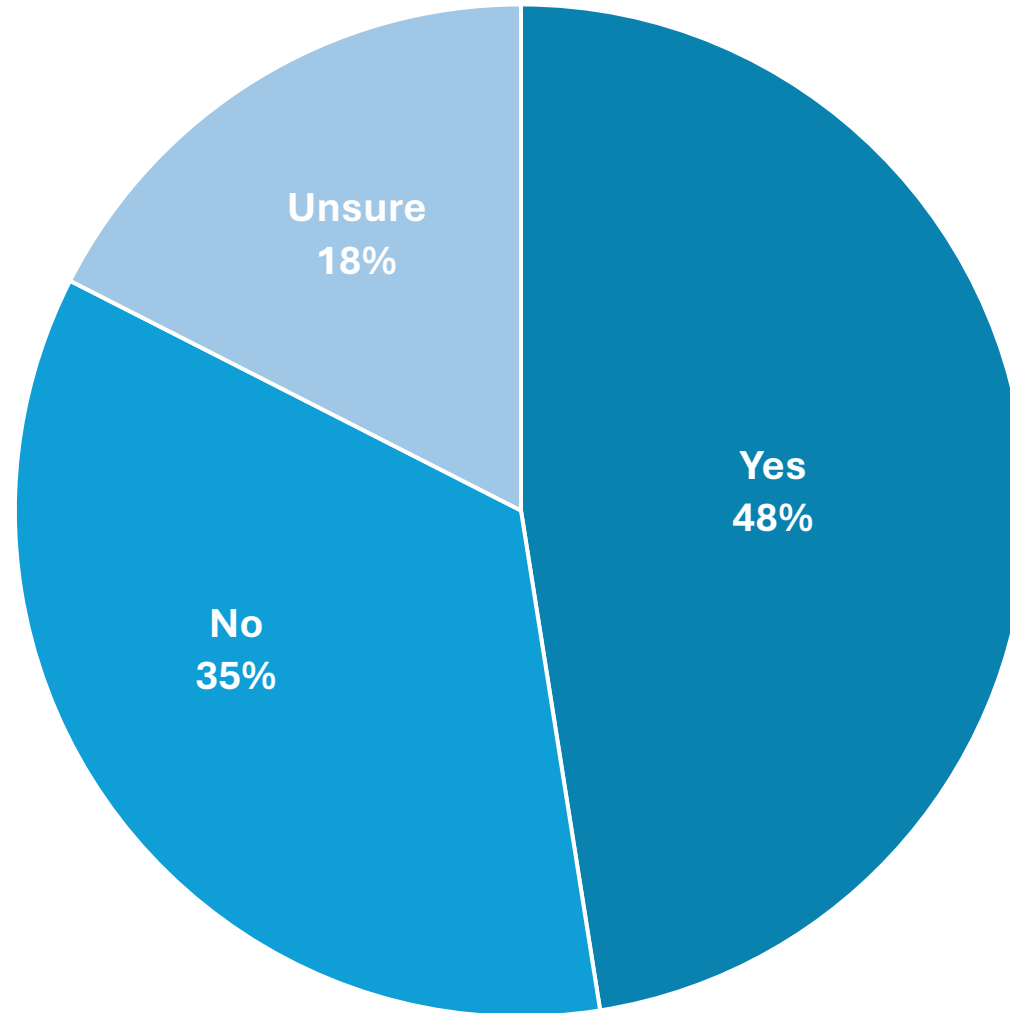
## What type of help have you been able to get in your community?

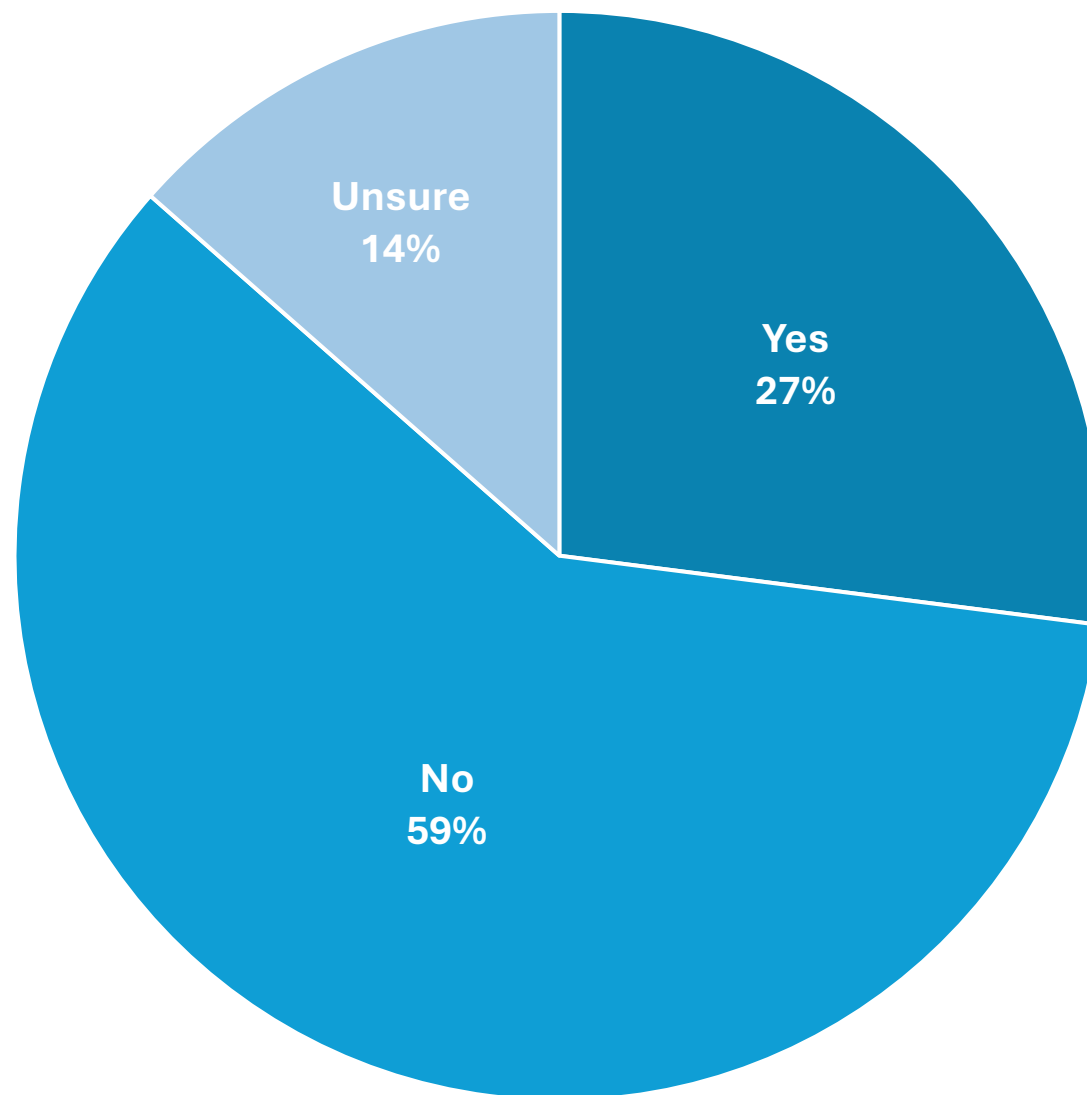

## What reason were you given for being denied services, if any?

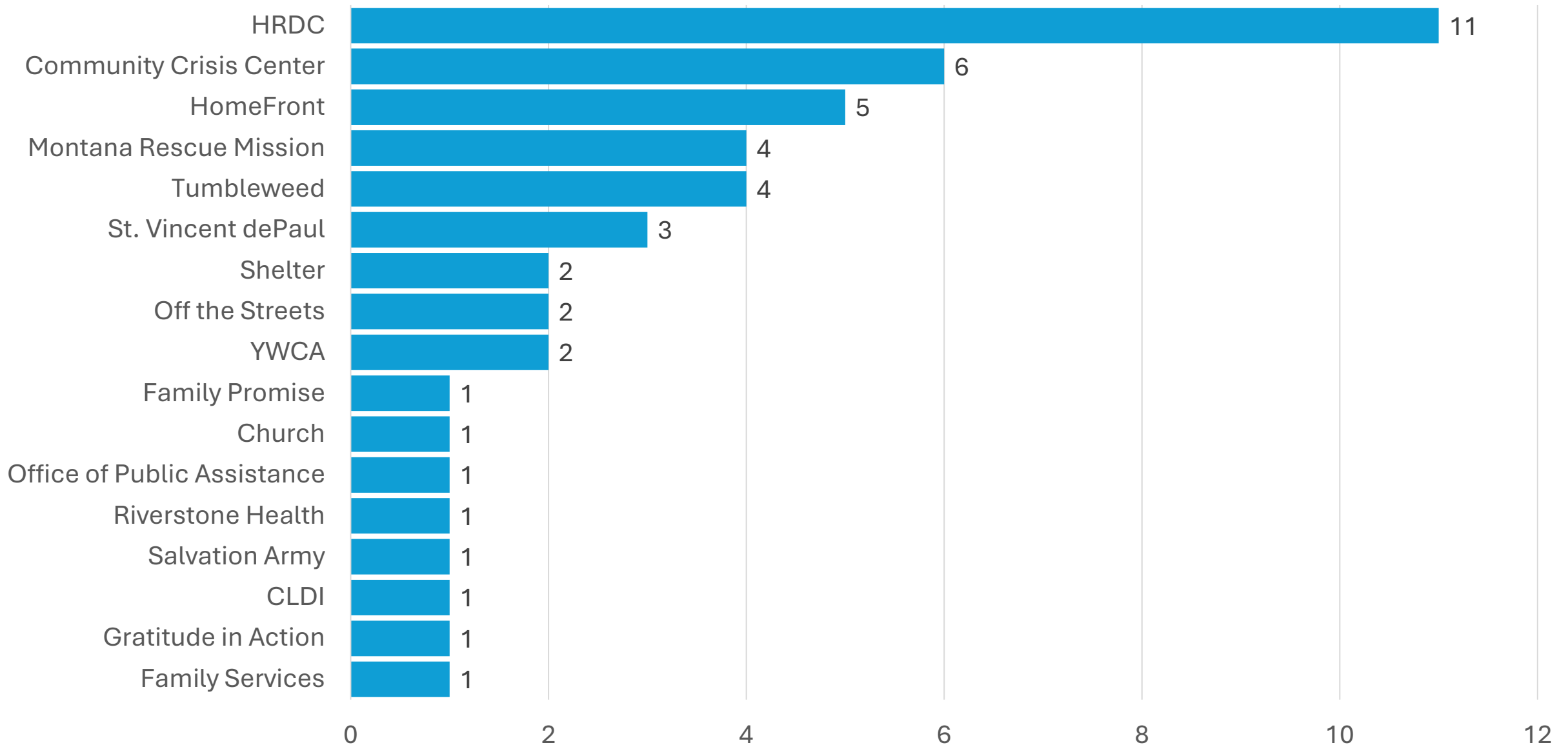
- “Paperwork, paperwork, paperwork... very very complicated process”

**If you experienced wrong, unfair or harmful treatment, do you know where to file a complaint (or grievance) to get help or resolve the issue?**

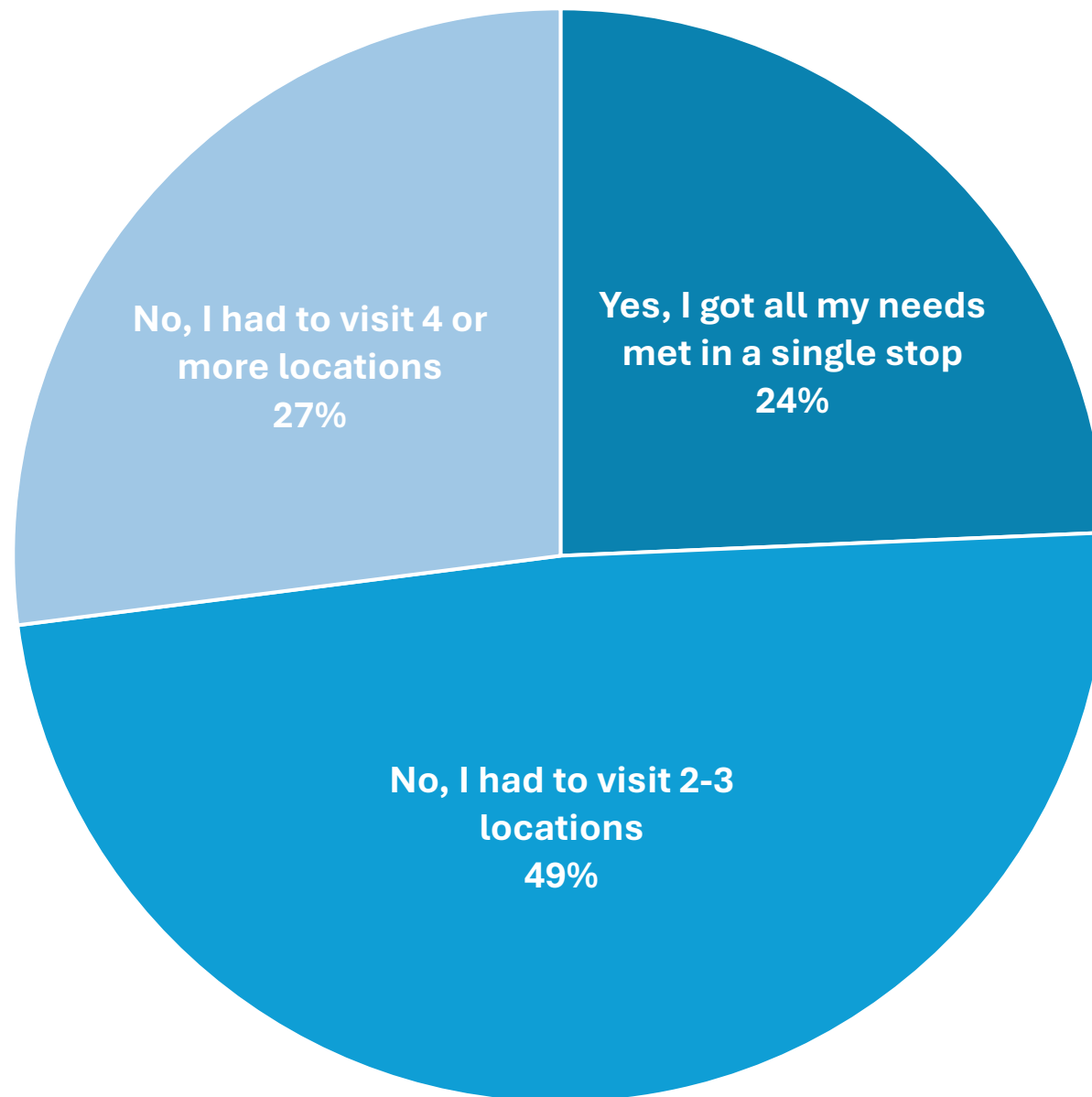




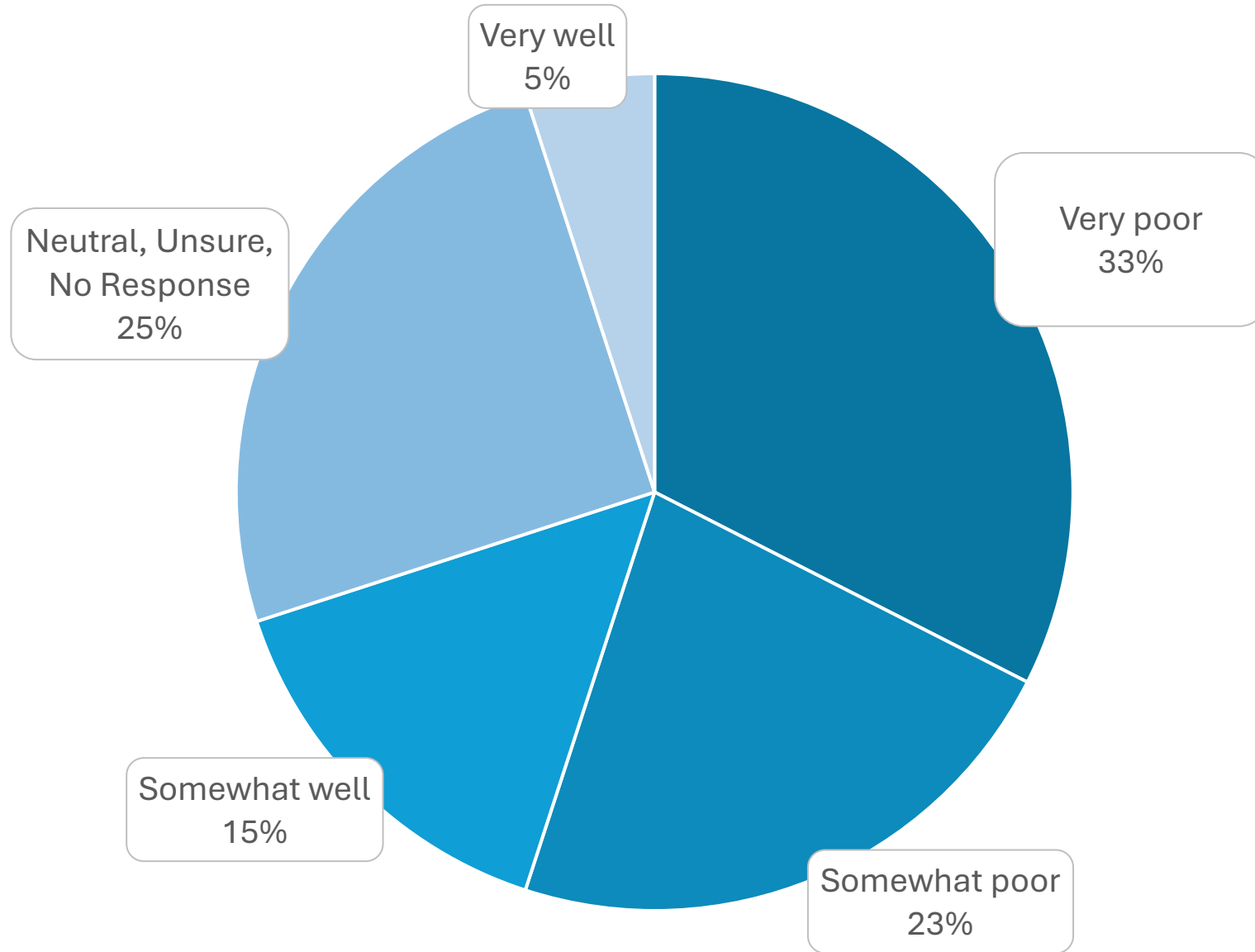
## If you knew someone who needed help with housing, shelter or supportive services, where would you recommend they go first?



**When seeking help, were you able to get your needs met at one location?**




**Overall, how do you feel your community is doing to get people the support they need for their housing journey?**



## When it comes to accessing services, how could the process be improved?

- “...a little more hand holding. It would be amazing if the various services could share info with each other...”
- “Access needs to be accessible”
- “Navigation Center – one stop shop is badly needed...”
- “It would be great if everybody worked together so they could actually tell me where there was hope and help available on the day I needed it”
- “The amount of questions asked upon intake is overwhelming...”
- “Have housing for felons”
- “It can be difficult to know where to start and what one qualifies for”
- “For people to not judge book by its cover”
- “Less running around when we don’t all have cars or rides and the bus is kinda sketch”
- “More beds and food”
- “...Maybe agents could fill out the paperwork for us...”
- “More of community having knowledge”
- “Less rules right away and more time for people to settle in and trust you”

## **What were or are your biggest challenges to getting housing assistance and/or finding housing?**

- “Affordable housing is very hard to come by”
- “Rental prices and housing prices are too high”
- “Move in costs”
- “There’s never enough money available for rental assistance”
- “Not having the money for application fees and deposit”
- “The application process”
- “Bad credit”
- “Finding a landlord to accept my past”
- “Mental health and substance abuse”
- “Not having my own transportation”
- “Transportation is a huge barrier”
- “Too many people on lists”
- “Waitlist...”
- “Government funding not matching local cost”

## Other Feedback

- “Why are people on the street continuously arrested for being in-house or mentally unwell?...”
- “Homeless community are human beings and should be shown grace and compassion. Instead, I am made to feel it is my own fault.”
- “There is not enough affordable housing in the community. I relapsed multiple times while waiting to get into treatment.”
- “...Billings gets very cold in the winter, There’s a lot of illegal drug activity and illegal drug use. Billings needs a day shelter and a night center for this group of people. Their mental illness mixed with addiction won't let them be law abiding, productive citizens.”
- “Why does the Mission and Off the Streets charge people money”
- “We need to reform the judicial civil departments automatic siding with the landlords lies in court. Tenants should be offered attorneys if the landlord has one.”
- “...the current system appears to be broken and agencies do not talk to one another and ask for the same data repeatedly every place I go. This is overwhelming as a homeless person, and certainly not best practices. There needs to be a better system, whereby a centralized cloud based platform can be used and accessed by all providers in a community And then the state cover the cost of maintaining and controlling that platform...”
