

Resolution 01-17649

RESOLUTION OF INTENT TO ANNEX WHOLLY SURROUNDED LAND TO THE CITY OF BILLINGS

WHEREAS, MCA 7-2-4501 authorizes annexation of contiguous land, and

WHEREAS, under MCA 7-2-4502 there is no legal right to protest this specific annexation, and

WHEREAS, said annexation would be in the best interest of the City of Billings and the inhabitants of the area to be annexed, and

WHEREAS, the Planning Department shall report to the City Council prior to the Public Hearing as provided in MCA Title 7 Chapter 2 Part 47, and

WHEREAS, a hearing shall be scheduled and held as provided in MCA 7-2-4314,

WHEREAS, the City Clerk should give notice as provided in MCA 7-2-4312 and 7-2-4313, and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF BILLINGS, MONTANA, AS FOLLOWS:

1. INTENTION TO ANNEX: Pursuant to MCA 7-2-4501, the City Council hereby expresses its intent to annex land contiguous to the City of Billings described as follows:


**Lots 5-6, Block 6, Rush Subdivision, 2nd Filing


2. REPORT: That a report as required by MCA 7-2-4731, 4732 shall be prepared and filed with the City Administrator. Said report shall be approved by the City Council at least fourteen (14) days prior to the public hearing and said report shall be available to the public at the office of the City Clerk. Copies of a summary of said report shall be made available for distribution.
3. PUBLIC HEARING: That a public hearing on the proposed annexation shall be held on the next regular Council Meeting after the expiration of the 20-day comment period in MCA 7-2-4313(2) at the Council Chambers, City Hall, Billings, Montana. The public hearing has been scheduled for **February 12, 2001** at 7:30 p.m. in the Council Chambers, located on the second floor of the Police Facility at 220 North 27th Street, Billings, MT.
4. NOTICE: That the City Clerk shall give notice of the hearing once a week for two (2) successive weeks as provided in MCA 7-2-4312 and 7-2-4313.
