Montana, as per Section 22-601 BMCC, requesting discontinuance and vacation of **the
alley located in Block 273, Original Town of Billings** as described hereinafter; and

WHEREAS, a public hearing was properly noticed and held as required by
law.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF
THE CITY OF BILLINGS, MONTANA, AS FOLLOWS:

1. **DISCONTINUANCE AND VACATION.** Pursuant to Sections 7-14-4114
and 7-14-4115, M.C.A., **the alley located in Block 273, Original Town
of Billings** and more particularly described on ***Exhibit "A"*** attached,
is/are hereby discontinued, abandoned and vacated.
2. **PUBLIC INTEREST.** The discontinuance, vacation and abandonment of
the above described **the alley located in Block 273, Original Town of
Billings** is in the best interest of the public and can be done without any
public detriment. Ownership of the vacated area will revert to the adjacent
owner – School District No. 2 of Yellowstone County.

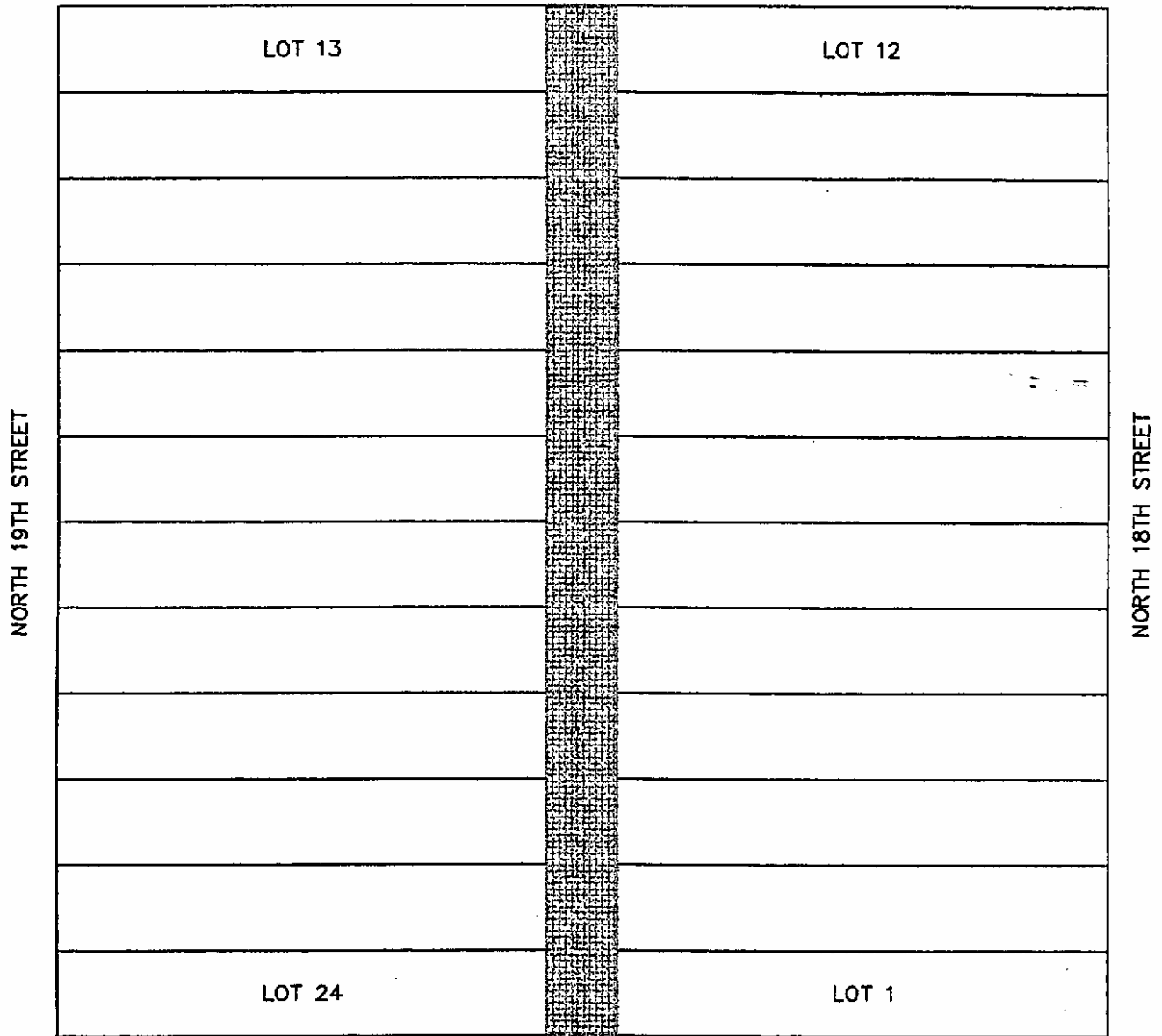
