

## RESOLUTION NO. 03-18006

### **A RESOLUTION AMENDING THE BOUNDARIES OF SPECIAL IMPROVEMENT LIGHTING MAINTENANCE DISTRICTS 10, 160, 257 and 263.**

WHEREAS, properties within Special Improvement Lighting Maintenance Districts 10, 160, and 257 are no longer receiving or will not receive benefit of lighting from said districts; and

WHEREAS, Special Improvement Lighting Maintenance District 263 contains a non-assessable property; and

WHEREAS, pursuant to MCA 7-12-4335 the City Council may, by resolution, change the boundaries of any special improvement lighting maintenance district;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF BILLINGS, MONTANA:
